Statement of intent

Red Kite Learning Trust Mission, Values and Goals underpin and drive the following priorities:

- Building a 'Culture of Success'
- Developing the 'Recovery' curriculum
- Leadership Development
- IT innovation
- Improvement of Student Support structures to secure appropriate, successful and costeffective provision

AIM

To continue to improve the outcomes of our disadvantaged learners by a persistent and relentless focus on meeting their academic needs, improving their social/cultural capital and supporting them academically, financially and emotionally so that they may reach their full potential and allow them to access their aspirational 'next steps'.

All staff at the academy have the shared belief that every child, regardless of background, has the right to a high-quality education that enables them to reach their full potential.

All staff have the responsibility for ensuring that disadvantaged learners have the access to the highest quality of teaching and learning and rich curriculum that enables every learner, regardless of social economic background to achieve success.

Rationale

This policy is based around three important and interrelated pillars that aim to provide our

disadvantaged students with high quality teaching and the support and self-belief that they can succeed. These pillars are:

- Pillar 1: PURPOSE Ethos and Values
- Pillar 2: AMBITION Targeted support and improving social capital
- Pillar 3: EXCELLENCE High Quality Learning and Teaching



Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Attendance – our attendance data over the last 3 years indicates that attendance among disadvantaged pupils has been between 4-8 percentage points lower than for non-disadvantaged pupils.
	37% to 57% of disadvantaged pupils have been 'persistently absent' compared to 9% to 18% of their peers during that period. Our assessments and observations indicate that absenteeism is negatively impacting disadvantaged pupils' progress.
2	Engagement in Learning –SEMH needs and the associated disengagement in learning of a small cohort of students (mostly eligible for PP) is having a detrimental effect on their academic progress.
	There is a higher proportion of disadvantaged pupils attending Alternative Provision which decreases their curriculum offer and thus decreases their aspiration. Typically, around 50-60% of disadvantaged students have required behavioural interventions compared with 15-20% of non-disadvantaged pupils.
3	Pastoral – Our assessments (including wellbeing survey), observations and discussions with pupils and families have identified social and emotional issues for many pupils, such as anxiety, depression and low self-esteem. This is partly driven by concern about catching up lost learning and exams/ future prospects, and the lack of enrichment opportunities due to the pandemic. These challenges particularly affect disadvantaged pupils, including their attainment. During the pandemic, there was a three-fold increase in teacher referrals for support. Many disadvantaged pupils currently require additional support with social and
4	emotional needs and small group interventions. Aspiration – many of the parents of our disadvantaged pupils do not have positive experiences of school and did not have the opportunity to attend Post-16 or university. Disadvantaged pupils can have lower confidence and self-esteem than their peers which can negatively influence future aspiration planning.
	Last year, 46% of disadvantaged pupils have gone on to level 3 qualifications compared with 54% of non-disadvantaged pupils. All NEET students were disadvantaged.
5	Attainment – There is a significant gap between the attainment of disadvantaged pupils and non-disadvantaged pupils. In summer 2023, 47% of disadvantaged pupils achieved grade 4+ in both mathematics and English compared with 68.2% of non-disadvantaged pupils.
6	Literacy – a high proportion of disadvantaged pupils arrive on entry with low levels of English skills. Many disadvantaged pupils do not receive the same social and cultural experiences as their more advantaged peers. This impacts on limited vocabulary and the ability to apply learning to real life contexts. There is a need to 'know more and remember more' in summative assessment which places high importance on knowledge retrieval. Disadvantaged students have been identified as requiring additional support on knowledge retention strategies. Lower recall has been identified through work scrutinies, exam results and teacher feedback. Our Year 7 cohort for 23-24 indicate that just under ¼ of disadvantaged students have below chronological Reading Ages.

Intended outcomes

To achieve and sustain improved attendance for all pupils, particularly our disadvantaged pupils.	Sustained high attendance from 2025/26 demonstrated by: The overall absence rate for all pupils being no more than 5%, and the attendance gap between disadvantaged pupils and their peers being reduced to zero. The percentage of all pupils who are persistently absent being below 20% and the figure among disadvantaged pupils being no more than 5% lower than their peers.
To reduce the number of behavioural interventions required amongst all pupils, including those who are disadvantaged.	By the end of our current plan in 2025/26, the number of behavioural interventions has decreased among all pupils. The gap between disadvantaged pupils and non-disadvantaged pupils has decreased to 0%. Currently it is 5-6%.
To achieve and sustain improved wellbeing for all pupils, including those who are disadvantaged.	Sustained high levels of wellbeing from 2025/26 demonstrated by: Qualitative data from student voice, student and parent surveys and teacher observations. A significant increase in participation in enrichment activities, including those who are disadvantaged.
To improve the aspiration of all students, including those who are disadvantaged.	Disadvantaged students have access to careers appointments, educational visits and talks across all subjects. Current provision is marked against the Gatsby benchmarks and a comprehensive careers and destinations programme is taught. Impact on motivation and therefore achievement.
Improved attainment among disadvantaged pupils across the curriculum at the end of KS4, with a focus on EBacc subjects.	By the end of our current plan in 2025/26, 25% or more of disadvantaged pupils enter the EBacc. In the last 3 years this figure was 8-15%. 2025/26 KS4 outcomes demonstrate that disadvantaged pupils achieve and average Attainment 8 score of 4. Currently it is 3.67. The gap between disadvantaged and non-disadvantaged pupils attaining a grade 4+ in both mathematics and English decreases over this time period. Currently the attainment gap is 21 percentage points.
Improved reading comprehension and literacy skills among disadvantaged pupils across KS3.	Reading comprehension tests demonstrate improved comprehension skills among disadvantaged pupils and a smaller disparity between the scores of disadvantaged pupils and their non-disadvantaged peers. Teachers should also have recognised this improvement through engagement in lessons and book scrutiny.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2022 to 2023 academic year.

Our evaluation of our pupil premium strategy and recovery plan for 2022/23 indicated that we were successful in providing access to technology to students, in developing knowledge and recall of specialist vocabulary, and in using more informal assessment so that lessons were pitched appropriately for students.

Our evaluation indicated success with the literacy tutoring intervention (part of the catch-up funding was used to facilitate this). The outcomes in literacy has resulted in the expansion of this intervention for the next academic year to ensure maximum impact.

There was a large focus on literacy over the year. The Director of Communication worked to continue to raise the profile of this and it is now embedded in form time sessions, for example through The Crawshaw Book Club. The canon selected for this is designed to increase cultural capital for all students. This is facilitated by tutors. Wider Reading has had a positive impact on all students across all subjects. There has been an improvement in literacy across the Academy and evidence of the Literacy Strategy (part of the Learning and Teaching Policy) in books and in observed lessons. Quality of written work has improved. This will continue to be a focus for the current academic year with the appointment of a TLR project post with a specific focus on Disciplinary Literacy.

Assemblies are centred around raising cultural and social capital and awareness. They are a core element of the Personal Development curriculum. Praise assemblies featured regularly throughout the year, celebrating student success. Lesson observations and learning walks indicate that expectations of students are high, and that positive reinforcement and aspirational language is being used.

Extra-curricular trips and enrichment activities are embedded with a clear emphasis on choosing disadvantaged students first for these opportunities. We were delighted as a school to be awarded the Quality in Careers Standard, demonstrating that our work towards the Gatsby benchmarks is exemplary and that we are prioritising and enhancing our students' careers education. We held many aspiration events over the year across all year groups. Again, disadvantaged students were encouraged to attend these first.

More emphasis was placed on ensuring disadvantaged students applied for appropriate, aspirational courses after Crawshaw. All disadvantaged students were given regular careers meetings and were helped to make their applications. Of the 9 students for whom we had no record of onwards next steps, all were disadvantaged.

Attendance was a big focus for us during the year. Our overall attendance gap between disadvantaged and non-disadvantaged students was 8 percentage points. Our persistent

absentee figure rose for disadvantaged (49.2%) and fell for non-disadvantaged students (18.9%).

We used part of our recovery funding to employ a teacher focussed on catching-up Year 7 students so they are 'secondary ready'. In the discussions for who would benefit from this the most, disadvantaged students were chosen as a priority. Students completed extra numeracy sessions and we were pleased with the progress made.

We also used our recovery funding to employ Crawshaw staff as tutors. We focussed on mathematics, English, science and history and had disadvantaged students from years 7 to 10 completing weekly sessions within our ReSet provision.

The use of Microsoft 365 (in particular Teams) has been embedded and subjects used this platform to help students access any work missed due to any missed learning. This is alongside other learning platforms, including Senca, Century and Sparx Maths. Disadvantaged students were given a government laptop if needed to ensure parity in IT accessibility.

Teachers plan their lessons with progress in mind. They use the Academy framework planning sequences that give a purposeful and informative start to lessons and also allow time for students to apply new knowledge and skills. Memory for learning strategies are utilised by teachers to help students to improve students' retention and retrieval of knowledge. Meaningful homework is set that consolidates knowledge and improves retention. Class data sheets are now an embedded part of all teachers' toolkit for each of their classes. These highlight disadvantaged students (along with other groups) and have strategies for improving learning and attainment.

Our GCSE results show a narrowing of the gap for students achieving 5 GCSE grade 9-4 including mathematics and English to 18 percentage points (42% compared to 60%). In 2019 this was 46 percentage points. Part of this success was our intervention with key students in mathematics and English during the school day. Our average points score for disadvantaged students increased from 2019 (3.15) to 3.67 (compared to 4.35 for all students). 32% made positive progress across all subjects.

Our internal evidence shows that the legacy of the pandemic still remains, given the disruption caused by the lockdowns. Our current Pupil Premium Strategy and recovery curriculum continues to focus on addressing this impact.
